# **Chefs, Cooks, Line Cooks**

## **Applications Required**

- Skilled worker category
  - *Employer and Worker Application for a Skilled Occupation (ABPNP 005)*
  - *Employer Compliance Declaration Form*
  - *Application for Provincial Nomination (ABPNP 003)*
- Read all instructions carefully



# **Chefs, Cooks, Line Cooks**

## **Supporting Documents Required**

- *Employer & Worker Application for a Skilled Occupation (ABPNP 005)*
  - Copy of candidate's work permit(s)
  - Copy of current Labour Market Opinion (LMO)
  - Copy of most recent Application for a LMO
  - Job description
    - If unable to provide Application for a LMO
  - Copy of signed employer-employee contract



# **Chefs, Cooks, Line Cooks**

## **Supporting Documents Required**

- *Application for Provincial Nomination (ABPNP 003)*
  - Proof of completion of culinary trade requirements
  - Reference letters for minimum work experience required
  - Current employer must also provide a reference letter



# **Chefs, Cooks, Line Cooks**

## **Supporting Documents Required**

- Employer requirements
  - Organizational chart for kitchen
  - Evidence of official seating capacity



# Foodservices Industry (Pilot Project)

## Applications Required

- Semi-skilled worker category
  - *Employer Application – Semi-Skilled Worker Category (ABPNP 001)*
  - *Employer Compliance Declaration Form*
  - *Employer and Worker Application for a Semi-Skilled Occupation (ABPNP 002)*
  - *Application for Provincial Nomination (ABPNP 003)*
- Read all instructions carefully



# Foodservices Industry (Pilot Project) Supporting Documents Required

- *Employer Application - Semi-Skilled Worker Category (ABPNP 001)*
  - Foreign Worker Settlement Plan
  - Evidence of Accommodation Arrangements



# **Foodservices Industry (Pilot Project)**

## **Supporting Documents Required**

- *Employer & Worker Application for a Semi-Skilled Occupation (ABPNP 002)*
  - Copy of candidate's work permit(s)
  - Copy of current Labour Market Opinion (LMO)
  - Copy of most recent Application for a LMO
  - Job description
    - If unable to provide Application for a LMO
  - Copy of signed employer-employee contract



# Foodservices Industry (Pilot Project)

## Supporting Documents Required

- *Application for Provincial Nomination (ABPNP 003)*
  - Proof of completion of high school education
    - Equivalent to Alberta standards
  - Reference letters for minimum of three (3) years of work experience in directly related job(s)
  - Current employer must also provide a reference letter
  - Canadian Language Benchmarks Assessment (CLBA)
    - Minimum level of 4 in each area
    - TOEFL or IELTS equivalencies considered

- *Copy of Application for Permanent Residence*
  - Application for Permanent Residence in Canada
    - IMM 0008 Generic
  - Schedule 1: Background / Declaration
    - IMM 0008
  - Additional Family Information
    - IMM 5406
  - Schedule 4: Economic Classes - Provincial Nominees
    - IMM 0008



# *Employer Compliance Declaration Form*

- Supporting documents are not required
- Employer may choose to submit supporting documents depending on responses



# Filling Out The Forms

- Answer all questions or sections of the applications
- If questions do not apply, answer “N/A” (Not Applicable)
- Provide original PNP forms
- Provide copy of CIC forms
